# Haldimand Older Adult and Caregiver Health Drop In Day November 2023

The Greater Hamilton Health Network held their very first Haldimand Older Adult and Caregiver Health Day on November 14th.

We saw a total of 85 participants. There were 13 organizations offering 21 services. Haldimand Public Health saw 12 - walk ins for their COVID/Flu immunization clinic. The event feedback survey indicated that 100% of participants were happy with the services and met their needs, and 2/23 used services they don't normally use.

The GHHN will continue to offer these events and plan to rotate locations through the area to ensure effective reach.

# 2024 GHHN Strategic Priorities Melissa McCallum

We are pleased to present our GHHN strategic plan refresh for 2024! This year has brought new light and direction for Ontario Health Teams (OHTs).

In September, it was announced that the Greater Hamilton Health Network (GHHN) is one of 12 OHTs chosen to implement an advanced workplan and work towards OHT designation at a rapid rate. With this advancement comes the introduction of new work priorities like home care and integrated clinical pathways and continuation of important focused areas such as primary care, system navigation, integrated population health and governance. The GHHN remains committed to supporting locally important initiatives as well as provincial priorities and we will do so with a lens of creating an equitable care system with the person at the center.

We look forward to continuing to engage with patients and partners as we move this work along. Thank you for helping us lead the way provincially!

### Digital Health Update Ceara Holditch

#### eReferral Update

- Ontario Health is aiming to increase flexibility with preferred eReferral providers by seeking up to 4 vendors to join a provincial vendor of record (VOR), with the goal of continuing the spread and adoption of eReferral services. The VOR will be issued in the spring of 2024.
- Ontario Health will maintain the current vendor relationship for existing Ocean licenses until March 2028, after which the licenses will transition to one of the provincial VORs.
- All projects or requests requiring eReferral licenses that have signed agreements will continue to move forward. Net-new requests or expansion of pre-existing work where increased licensing is required will be put on hold until the new provincial VOR is established.

#### Patients before Paperwork (PB4P) Initiative

 Ontario Health is coordinating a clinicallyguided initiative called Patients Before Paperwork (PB4P), which will support several workstreams relating to referrals, prescriptions, lab requisitions, medical notes, and administrative processes. The focus of PB4P will be on change management and leveraging integrated digital health solutions to streamline workflows and reduce the administrative burden of frontline providers.



# Urgent Care Ontario offering virtual appointments

- Virtual urgent care appointments are available for adults and kids with urgent, non-life threatening medical issues through <u>Urgent Care Ontario</u>. Virtual services are available to people living in the Ontario Health West Region, from Waterloo to Windsor and Tobermory to Niagara Falls. Urgent Care Ontario is led by St. Joseph's Healthcare Hamilton in partnership with London Health Sciences Centre Children's Hospital, Niagara Health and Hamilton Health Sciences.

#### Provincial Solution for Remote Care Management

 Ontario Health has completed the procurement of the new provincial solution that will support Remote Care Management Programs; the successful vendor is Telus Health Solutions. The configuration and implementation planning will begin in January 2024.

### **Provincial Navigation Update**

- OHT content is now live on <u>Health811 Health811</u> (ontario.ca). Users can select their community based on postal code and will be presented with a curated selection of services and information on the OHT landing page, Greater Hamilton Area.
- Episodic Access to Virtual Care (EAVC) pathways launched at the end of October 2023. Health811 advisors will be able to screen for eligibility for EAVC visits and will direct the patient to the appropriate regional EAVC website to book an appointment

### **Online Appointment Booking (OAB)**

- The GHHN has launched the highest number of OAB licenses in the province, with 325 licenses across 53 sites and over 2,800 website views. An additional 50-75 licenses are expected to be live by March 31, 2024.

#### Need a Bike Rack?

The GHHN is excited to share another successful project in collaboration with students from McMaster University's second year Advocating for Sustainability course and third year Implementing Sustainable Change course. Students worked with the GHHN and the City of Hamilton to 1) review the City's bike rack request form and ensure it's as user friendly as possible, 2) promote completion of the bike rack request form at community and social service agencies in downtown Hamilton, 3) develop a bike rack location assessment checklist, and 4) assessing potential bike rack locations at community and social service centres that have requested one.

We are excited to say that within just four short months, not only were all project goals met, but two bike racks were installed just outside Shelter Health Network's space at 850 King Street East!
